

INTRODUCTION

- The purpose of this study was twofold:
 - 1) Capture a representative sample of the perceptions of residents and property owners of Cooke City and Crandall on winter access and recreation.
 - 2) Further explore other topics in the region such as quality of life, summer tourism and recreation, and plans for the future.

 The target audience included both those who live in Cooke City/Silver Gate/Colter Pass and the Crandall area year-round as well as those who either own property and live elsewhere or own a second home in the area.



Survey Distribution

- Respondents were contacted via a mailed paper survey with a password protect option for respondents to alternatively participate online.
- The mailing of these paper surveys was done in coordination with the Cooke City, MT and Cody, WY USPS postmasters, who delivered surveys to potential respondents in Cooke City, Silver Gate, Colter Pass, and along the Crandall Road.
 - Cooke City Post Office forwarded surveys where there was forwarding set up on the account.
- To better capture secondary homeowners and those who get their mail elsewhere than these above locations, mailing address data was gathered from the State of Montana and Wyoming property records.
 - This data was used to further refine the data and capture respondents that may have been missed in initial postal deliveries.

• Surveys were accepted online and by mail-in from October 13 thru December 7, 2023.


 Approximately 210 surveys came from the Cooke City/Silver Gate/Colter Pass area with just over 80 coming from the Crandall area.

YEARS IN GREATER COOKE CITY AREA


How many years have you lived in the Greater Cooke City Area? (Capped at 70 Years)





AREA OF THE REGION


In which part of the Park County, WY / Park County, MT Region do you live or own property?





RESIDENCE TYPE


What describes your residence in the Greater Cooke City Area?





TIME SPENT IN AREA


How much time do you spend in the Greater Cooke City Area?





HOME OWNERSHIP


Do you own or rent your residence in the Greater Cooke City Area?






EMPLOYMENT

Are you employed in the Greater Cooke City Area?




Do you need to travel outside of the Greater Cooke City Area for work?









Would you say your overall quality of life in the Greater Cooke City Area has been:






What are the biggest impacts or challenges affecting you in the Greater Cooke City Area?










AGE

KEY FINDINGS



• Respondents of the Cooke City/Silver Gate/Colter Pass (Greater Cooke City) area are largely made up of people who've lived in the area for 15+ years (59%) as a mix of primary (45%) and secondary (50%) residents.



 These respondents have identified the reputation of Cooke City, as well as the diversity of summer recreation opportunities as items that were ranked highly in terms of their importance to, and current satisfaction in meeting, quality of life in the region.



 Availability of workforce, variety of restaurants, and emergency services showed large differences in their average level of importance and their average level of satisfaction; illustrating a need that is not currently being met to the expectations of the Greater Cooke City respondents.



KEY FINDINGS



• Additional challenges that the Greater Cooke City respondents identified were winter access to/from the Greater Cooke City area, lack of housing, and ability to find workforce staffing.



• A majority of Greater Cooke City respondents agreed that Cooke City relies on winter tourism (82%), that the Greater Cooke City Area would benefit from US 212 east of Cooke City being plowed (58%), the winter visitors are provided a high-quality experience (52%), and that plowing US 212 east of Cooke City is necessary to ensure efficient emergency services (53%).



• Consistent with the high share of Greater Cooke City respondents that ranked emergency services and safety and security as important to the community's quality of life, 44% of respondents chose the hypothetical scenario of opening and maintaining US 212 east of Cooke City with additional action to create alternative trails and parking. Just over one-third of respondents (36%) wanted to continue to leave US 212 east of Cooke City unplowed.

CONCLUSION

- Respondents have identified several challenges and concerns that impact their community's
 quality of life. More than a third of the Greater Cooke City area respondents believe that overall
 quality of life in the area is declining, with another third saying it's staying the same.
 - Winter access to/from the Greater Cooke City Area is top of list, with this challenge further underscored by how highly emergency services and safety and security ranked for the people of Cooke City/Silver Gate/Colter Pass.
 - Economic issues facing the region followed, with the respondents identifying a lack of housing and ability to find workforce staffing the second and third ranked challenges for the community, respectively.
- However, this group has also expressed a great deal of satisfaction with their summer recreation opportunities, the reptation and heritage of Cooke City, and their schools. Indicating that while there's much that respondents want improved, there's also much that they're already quite satisfied with.
- While it was clear that the Greater Cooke City area respondents know that winter access is a challenge for the community, both the decision on whether it's a benefit or detractor, as well as what ultimately should be done were largely split.
 - The greatest share of Greater Cooke City area respondents identified the current winter access to the area as a detractor from the visitor experience.
 - Consistent with this, the largest share of respondents opted to open and maintain US 212 east of Cooke City for through vehicle traffic and create alternative trails to, and parking areas near/in, Cooke City.






